

**ANNOUNCING THE 2024 CENTRAL VISAYAS REGIONAL ATHLETIC ASSOCIATION (CVIRAA) SPORTS MEET AND ITS SCHEDULE OF ACTIVITIES**

To: **Schools Division Superintendents  
All Others Concerned**

1. The Department of Education (DepEd) Region VII officially announces the conduct of the 2024 Central Visayas Regional Athletic Association (CVIRAA) Sports Meet on May 4-9, 2024, at Cebu City. This activity will be hosted by the Local Government Unit (LGU) of Cebu City and DepEd Division of Cebu City.
2. The "Winner-Take All Policy" for team sports shall be implemented while the measurable sports Qualification Standards shall be applied or be used only for qualification to the next level competition which is the Palarong Pambansa.
3. The participation, management, and involvement of the Schools Divisions in terms of the expenses incurred, including the Personal Accident Insurance (PAI) of the whole delegation to the 2024 CVIRAA Meet shall be charged against MOOE/Special Education Fund (SEF)/Fund Support for Sports/local and other available funds, subject to the proper accounting and auditing rules and regulations.
4. As agreed during the Management Committee Meeting conducted last February 25-26, 2024, Schools Division Offices will provide Financial Assistance to the Host Division in the amount of PhP 10,000.00 per division.
5. The Schools Divisions are solely responsible of their own delegation amenities (like sleeping mats/foams, beddings, etc.), transportation, and enhancement of facilities (like kitchen, mess halls, additional shower rooms, drainage, etc.) for the comfort and convenience of their athletes, coaches, delegation officials and technical officials, not the host division and the billeting schools.
6. To start the planning and preparations of the crucial committees, there will be a Technical Conference to be attended by the Core Regional Screening and Accreditation Committee (RSAC) members, Division SAC Chairperson, Division Sport Officers (DSOs), Tournament Managers, Host (Cebu City) Event Managers on March 7-8, 2024, at DepEd Ecotech Center. Travel expenses of the participants shall be charged to its respective Division Sports Program Support Fund or Division MOOE while food which will start with snacks to be served in the morning of March 7, 2024, until afternoon snacks of March 8, 2024, and accommodation will be for the night of March 7, 2024, shall be charged against Regional Sports Program Support

Fund/Regional MOOE subject to the usual government auditing rules and regulations.


7. In view of this, the Schools Division Superintendents are hereby enjoined to support and prepare a plan of action for their division delegation participation.
