





DATE : 21 March 2024

The **Boys Scouts of the Philippines** will conduct the 67th Annual National Council Meeting on **May 15 to 17, 2024** at the **Garden Orchid Hotel, Zamboanga City**.

The meeting aims to receive the reports of the National President, and the National Treasurer, updates from the Secretary-General, as well as elect four Regular Members to the National Executive Board, and to ratify proposed amendments to the BSP Constitution and By-Laws.

It is expected to host at least 800 Scout Leaders composed of Regional and Local Council Chairpersons, Regional and Council Scout Commissioners, Scout Executives, and Volunteer Lay Leaders nationwide.

Regional Directors, Schools Division Superintendents, and Teachers associated with the Department of Education may opt to attend the said activity provided that their participation will not hamper the conduct of classes in schools. The use of DepEd funds shall be subject to the approval of their respective approving authorities. The



same is also contingent upon its availability, and adherence to the usual accounting and auditing rules and regulations.
