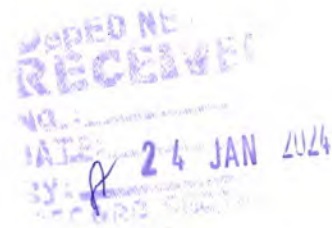

To make the conduct of this activity possible, the PSA would like to ask for the support and assistance of your good Office and allow PSA personnel to do information dissemination in schools under your supervision.


