





**ADDENDUM AND CORRIGENDUM RM # 179, S.2024 "ANNOUNCING THE 2024
CENTRAL VISAYAS REGIONAL ATHLETIC ASSOCIATION (CVIRAA) SPORTS MEET
AND ITS SCHEDULE ACTIVITIES**

To: **Schools Division Superintendents
All Others Concerned**

1. Pursuant to Republic Act No. 10588 otherwise known as Palarong Pambansa Act of 2013, the **2024 Palarong Pambansa** will be held in **Cebu City** on **July 9-16, 2024**. This national sports competition shall be participated in by athletes coming from both public and private elementary and secondary schools of the 17 regions all over the country.
2. As announced in Regional Memorandum No. 179, s. 2024, the Department of Education (DepEd) Region VII will conduct the 2024 Central Visayas Regional Athletic Association (CVIRAA) Sports Meet on May 4-9, 2024, at Cebu City. This activity will be hosted by the Local Government Unit (LGU) of Cebu City and DepEd Division of Cebu City.
3. In view of the absence of learner-athletes from their classes during the conduct of the CVIRAA, school heads are directed to adopt catch-up classes or alternative delivery mode to compensate for the number of lost hours incurred due to their participation in this sports competition.
3. There will be no competition for the Saludo. Only minor awards like Most Discipline, and Safest and Cleanest Delegation will be given.
4. The overall champion award will be based on the Olympic Medal count.
5. The members of the working committees, teacher-coaches, assistant coaches, chaperons, and technical officials shall be given with Service Credits or Compensatory Time Off CTO whichever is applicable for the services rendered on weekdays, but not to exceed five (5) days during the conduct of the CVIRAA beyond school days.
6. Technical Officials must submit to their Tournament Managers (TMs) a Medical Certificate to ensure that they are physically fit to join the CVIRAA 2024. All Tournament Managers and Technical Officials are required to attend the Refresher Course and the Solidarity Meeting.
