2023 National Climate Change Conference

Following the DRRMS Advisory No. 1 regarding the postponement and shift of modality for the conduct of the *2023 National Climate Change Conference* dated 13 November 2023, the Disaster Risk Reduction and Management Service (DRRMS) would like to inform all invited resource speakers, panelists, participants, and guests that **the event which was re-scheduled for 13 December 2023 will be postponed to 23 January 2024.**

Due to the recent emergency response actions being undertaken by the office brought by the effects of the Magnitude 7.4 Earthquake in Hinatuan, Surigao Del Sur, the DRRMS has decided to revert the event to its original plan of conducting a face-to-face conference instead of a virtual one. Given this, all personnel and guests involved are advised to arrange their travels on January 22-24, 2024 at the Development Academy of the Philippines, Tagaytay City. Attached herewith is the program of activities for reference.

With regards to the charging of travel expenses of panelists from selected schools, all travel and other allowable expenses shall be charged to the Division FY 2023 DPRP Funds. If the Division DPRP Fund is already depleted, the expenses shall be charged to the Regional DPRP Fund.
