
**CONDUCT OF CPC FUNCTIONALITY TRAINING**

1. This Office, through the Education Support Services Division – Learner Rights Protection Office (LRPO), will conduct a Child Protection Committee (CPC) Functionality Training for the primary purpose of strengthening the functionality of child protection committees in schools in Region VII. The activity shall be held on February 6-9, 2024 at DepED Ecotech Center, Sudlon, Lahug, Cebu City.
2. Participants to this activity are the DepEd Division Learner Rights Protection Focal Personnel and selected members of the Child Protection Committee in schools.

3. The objectives of this conference are the following:
  - a) To know and understand the DepED policies and issuances related to learner rights and protection;
  - b) To understand thoroughly the roles and responsibilities of the Child Protection Committee;
  - c) To know and understand the preventive measures in addressing child abuse, exploitation, violence, discrimination, bullying and other acts of abuse;
  - d) To know and understand the protective and corrective measures in addressing child abuse, exploitation, violence, discrimination, bullying, and other acts of abuse;
  - e) To know and understand the social behavioral change strategies for learner protection campaign;
  - f) Overall, to understand the ways and means on how to make CPCs effective, empowered, and functional to effectively ensure protection of learners' rights.
4. The activity shall start at 8:00 in the morning of February 6, 2024 and shall end on February 9, 2024 at 12:00 in the afternoon.
5. Expenses relative to the conduct of this activity shall be charged against Regional Office funds while traveling and other incidental expenses of participants shall be charged against Division/Local funds, all subject to the usual accounting and auditing rules and regulations. Furthermore, considering that February 9, 2024 is a holiday, employees shall be entitled to a one-day compensatory time-off, subject further to existing rules and regulations.
