



ANNOUNCEMENT OF DSPC WINNERS AND PARTICIPATION IN THE RSPC 2024

1. This office informs the field of the results of the Division Press Conference held on March 1, 2024, at NOHS and the participation of the DSPC winners in the Regional Press Conference on April 9–12, 2024, at Talisay City.
2. Attached is the list of DSPC Winners per category.
3. Registration of five hundred pesos (P500) for every student journalist and school paper adviser and meals for three days (April 9–11, 2024) shall be taken from the SEF of the province. While delegation uniform, transportation and meals on April 8 and 12, 2024, and other incurred expenses relative to RSPC shall be charged from the school MOOE/School Publication Fund, SEF, or other local funds.
4. Delegation uniforms for the management team and NOSPAA officers shall be charged from NOSPAA funds, while the SPAs and student journalists shall be taken from the school MOOE/SEF/School Publication fund/PTA/ or other local funds which is subject to COA rules. The price for the adult uniform is four hundred fifty (P450), and for the student journalists is three hundred thirty (P330) pesos only.


