

DATE : 10 January 2024

The Department of Education (DepEd), in coordination with the Philippine Sports Commission (PSC) and the Department of Interior and Local Government (DILG), shall conduct the **64th edition of the Palarong Pambansa** in Cebu City this year.

In view of the foregoing and to ensure that the members of the *Palarong Pambansa* Screening and Accreditation Committee – from the division up to the national level – are well-informed and knowledgeable of the rules and guidelines relative to the screening and accreditation, a **Conference of National, Regional and Division Accreditation and Screening Committee Members** shall be conducted from **February 05 to 09, 2024** at **Cebu Business Hotel, Cebu City**.

The Conference aims to:

- a. discuss areas for improvement and challenges confronted during the conduct of the 2023 *Palarong Pambansa*;

- b. orient and update the members of the Regional and Division Screening and Accreditation Committee on the revised rules on screening and accreditation of learner-athletes, coaches, assistant coaches, and chaperones;
- c. develop a system for the digitization of documents, preparation of PasSport for athletes/coaches/assistant coaches, and finalization of the masterlist; and
- d. concur with the timelines and expectations of the screening and accreditation process.

Target participants to the Conference are the chairpersons of the RSAC and DSAC or their respective authorized representatives, the members of the National Screening and Accreditation Committee (NSAC), regional sports officers and their respective IT personnel, members of the *Palarong Pambansa Secretariat*, and personnel from other relevant offices.

Participants are expected to be at the venue on February 05, 2024 and the first meal to be served is dinner. The last meal to be served is PM snacks on February 09, 2024.

Expenses such as food and accommodation of all participants, and travel expenses of the NSAC members from the DepEd Central Office and personnel from the *Palarong Pambansa Secretariat* shall be charged against the Physical Fitness and School Sports (PFSS) Funds, while travel expenses of NSAC members from the field and RSAC/DSAC chairpersons and/or representatives shall be charged against their respective MOOE/local funds, subject to the usual government accounting and auditing rules and regulations.
